
Oakland's Approach to Addressing Trash in Stormwater

- Implementing Direct Discharge Plan to focus on debris routes to waterways.
- How do we reduce the debris not being properly disposed or captured by Full Trash Capture? Overflow and illegal dumping.
- Oakland Public Works cleans thousands of tons of improperly disposed debris per year.
 - Proactive and Reactive Cleaning Crews
 - Homeless encampment cleanups at intervention events and weekly garbage runs.
- Cleanup alone is not moving the needle and can be a double-edged sword.
- Focus on enforcement and source reduction.
- Much of this work is needed in TMAs most heavily impacted by trash.
- Critical in Oakland for programs to address clean and safe neighborhoods as well as water quality. Overlapping supportive priorities.




Waste Generation Sources

- Last year, residents and businesses generated 218,791 tons of waste last year, (excluding recyclable or compostable materials, or materials hauled to transfer stations other than Davis Street).
- 8% of total collected by City of Oakland crews. Much of that is illegal dumping.



Oakland's Approach to Collecting Illegal Dumping

- FY 2021-2022, the City estimated spending approximately \$13 million on the issue of illegal dumping.
- Debris removal is primarily managed by the City's
 Keep Oakland Clean and Beautiful Division
 - 58 budgeted, full-time positions for debris removal in the city ROW and homeless encampments.




Debris Collection at Homeless Encampments

- Encampment Management Team
 - Deep Cleaning
 - Partial Closure/Closures
 - 200+ sites on list for interventions
- Weekly garbage runs at encampments
 - Containerized ~19 locations
 - Non-Containerized ~43 locations





- Requests for services (calls, emails, and SeeClickFix)
- Discrete debris pickup events
- Proactive & Reactive
- 6 months in 2023
 - 22,445 requests for service
 - 32,653 debris pickups



Environmental Enforcement Unit

- Relaunched in 2018
- 8 Environmental Enforcement Officers, a Clean Community Supervisor, and an Administrative Analyst
- Enforce illegal dumping restrictions and regulations
- Citation authority for mandatory trash service (OMC 8.28)
- Conduct forensic investigations & monitor surveillance cameras
- April 1, 2023 March 31, 2024: 570 citations issued.



Surveillance Camera Program

- Launched March 2022
- 16 Portable Observation Devices (PODS) at dumping hot spots
- First year ~500 dumpers
- Up to 50% of dumpers with license plates caught on camera cannot be identified.
- Addition of License Plate Readers approved in July 2023.
- Last year because of lack of LPR, only able to identify 59 dumpers on camera.
- Retrofitting existing cameras + 15-30 new cameras this year.



Property Owners' Responsibility for Trash Service

- Oakland Municipal Code Section
 8.28.100 all property owners must have trash service
- Barriers to Proper Trash Disposal?
- Free Services Available to Residents
 - Curbside Bulky Pick Up (1-2 times per year)
 - Free drop off at Davis Street (1-times per year)
 - Bulky Block Parties (Monthly Jan Oct)



Trash Cart Pilot Container Upgrade Program

- Collaboration with Waste Management of Alameda County.
- One trash route along International Boulevard.
- Larger trash containers at no extra cost for three months.
- Equity in trash rates: Residents select the size of their trash container based on cost rather than need.
- Small can approximately 40% more in per gallon.
- Stepping up enforcement against businesses in the area without trash service.
- Overages in pilot area significantly reduced (74%).

Container Size	Monthly Cost	Per Gallon Cost
20 gallons	\$51.76	\$2.59
32 gallons	\$58.77	\$1.84
64 gallons	\$103.67	\$1.62
96 gallons	\$155.79	\$1.62





Enforcement of Customers Without Trash Service

- Residential and Commercial Customers are treated differently
- Residential property owners without service are deemed a nuisance.
 - City will sign them up for service.
 - If bill is not paid, can lien property.
- Commercial business without service or does not that pay bill is simply cut off from service and left to deal with waste services on their own.
 - No lien mechanism for commercial property owners.
 - No mechanism in OMC to collect payment from delinquent commercial property owners.
 - 2021 27,422 businesses in Oakland.
 - 4,500 or more may be without proper service. *That trash is going somewhere.*
 - Cart Upgrade pilot program: 19% (13 businesses)
 - Oakland Fresh Initiative, 11% (128 businesses) without service.
 - Through citations, now at 100% compliance and 90% compliance.



Waste Hauling – Exclusive Franchisee and Other Haulers

Oakland is an exclusive franchise community for residential and commercial mixed material waste, organics, and recycling.

- Waste Management of Alameda County (WMAC) mixed solid waste and organic materials.
- California Waste Solutions (CWS) residential recyclable materials.

Exceptions

- Commercial businesses may hire non-exclusive franchise (NEF) haulers to remove recyclable materials from their properties.
- 2. Construction and demolition debris. 30 non-exclusive **Construction and Demolition Franchise Agreements** (CDNEFA).
- 3. Haulers like 1-800 Got Junk can receive a business license and provide removal and hauling services to Oakland residents.

Requires regulation and tracking to ensure debris is properly disposed.

Enforcement Of Illegal Construction and Demolition Debris Haulers

- Unscrupulous and illegally-operating haulers.
- As of FY 2021-2022 enforcing Construction and Demolition
 (C&D) debris hauling requirements. Building permit holders
 may only hire haulers with C&D non-exclusive franchise
 contract.
- Amendment OMC Section 15.34 more construction projects subject to C&D debris recycling and hauling requirements.
- Construction and small remodel projects in frontline communities vulnerable to contractors dumping C&D debris.



Residential Issues

- Container service price factor may be a contributing factor to illegal dumping.
- Pilot container upsizing program can cost-neutral upsizing citywide help alleviate this burden?
- Targeted outreach to understand the barriers to use of existing services.

Commercial and Business Issues

- Commercial property owners responsible for businesses on their property.
 City needs cost collection authority.
- Street litter containers abuse likely exacerbated by businesses that lack service.
- Need to continue enforcement of C&D haulers and ensure NEF haulers are registered.

Adaptive Management

- Complex issue requires attention and vigilance to learn from initiatives and grow the program over time.
- To ensure equity, achievements in one area of the city should not result in deterioration of conditions in another.
- Solve the issue rather than move it from location to location.
